Dogs: Bordetella, Rabies, DHPP, and a negative fecal exam must be currently up to date *(unless directed otherwise by your veterinarian)*.

Cats: Rabies, FVRCP, and a negative fecal exam must be currently up to date *(unless directed otherwise by your veterinarian)*.

Exotics: Annual exam must be up to date

We feed a high quality AAFCO certified food for all feline, canine, and exotic boarders unless food is provided by you.

Any diets that are prescribed to your pet that are opened during their stay, will be applied to your account. Fees for medications that need to be filled or refilled during the time your pet is boarding will be added to your account. Medication administration fees apply.

***NEW!** If a true emergency occurs, we will always stabilize the patient until a decision has been made by discussion with the owner.

Please provide a local emergency contact in the event that outpatient care is necessary. We reserve the right to treat any contagious medical conditions such as external and/or internal parasites (fleas, ticks, worms), mild respiratory infections (kennel cough), etc. to avoid contamination for all boarders and staff. *If a non-emergent medical issue such as diarrhea, constipation, ear or eye infections, minor wounds, etc. arise while your animal is boarding, please check one of the following:*

Statement of Kennel Policy:

1. We board pets for our clients only. We charge board by the number of days the pet is here and the boarding location of the pet. Pick up is before 11am or another day will be charged.
2. We do not have overnight staff to monitor animals while boarding at our facility. Kennel staff hours are 7am-6pm.
3. We will try our best to honor client requests for specific boarding locations. However, we reserve the right to house boarded pets in an alternate boarding location (medical or for other reasons at our discretion).
4. Clients are not permitted in boarding areas during drop off. Please schedule a tour ahead of time if you would like to see the boarding facility.
5. Pets may be dropped off or picked up between 8:30 am and 5:30 pm Monday - Friday, and between 8:30 am and 12:00 pm on Saturday. Sunday pick up times are between 8:30 am and 9:30 am as well as 4:30 pm and 5:30 pm. We do not discharge pets on major holidays.
6. Personal items may be left at your own risk. We cannot be responsible for loss or damage. Any soiled bedding may be thrown away (or kept per request).
7. If a pet, which is presented for boarding, exhibits internal parasites (i.e. worms) or external parasites (i.e. fleas and/or ticks) appropriate treatment will be provided at the owners expense.
8. Southborough Veterinary Hospital cannot guarantee the health of any animal, but pledges to give appropriate care to all boarding pets. I hold this facility harmless for conditions that are often unavoidable in boarding environments, including but not limited to kennel cough, upper respiratory infection, and diarrhea.
9. Should the pet identified on this record become seriously ill, I request that Southborough Veterinary Hospital provide all medical/surgical treatment it deems necessary. I acknowledge that, in the event of my pet's illness, the staff at this veterinary facility may not be able to contact me immediately and therefore authorized to initiate appropriate treatment until I (or the pet's agent) can be reached. I agree to pay all related expenses associated with the treatment of my pet until I am available to discuss further care and fees with the attending veterinarian.

I agree to make complete payment to Southborough Veterinary Hospital at the time of discharge. I certify that my pet appears to be free of contagious disease and has not bitten anyone within the past ten days. I understand that if I fail to pick-up my pet within ten days of notification to the above address, my pet will be considered abandoned and will be handled in accordance with Massachusetts state law, and that doing so will not relieve me of my financial obligations.
